No. LG/CTP(LG)/2020/33/4 In exercise of the powers conferred by sub-section (1) of section 201 of the Punjab Municipal Act, 1911 (Punjab Act No. 3 of 1911) and subsection (2) of section 399 of the Punjab Municipal Corporation Act,1976(Act No. 42 of 1976), and all other powers enabling him in this behalf, the Governor of Punjab is pleased to make following amendments in the clauses 3.14.1(b) of the Bye-Laws called Bye-Laws, 2018" notified vide Municipal Building Punjab "The CTP(LG)/2018/3548 on 22.11.2018 to be read with subsequent amendments notified vide no. CTP(LG)/2019/727 dated 09.03.2019, notification No. CTP(LG)/2019/3977 dated 31.12.2019, notification No. LG/CTP(LG)/2020/1338 dated 03.06.2020 and notification No. LG/CTP(LG)/2020/1864 on 20.07.2020 as follows. These shall come into effect from the date of notification.

Clause No. 3.14.1 (b) of the The Punjab Municipal Building Byelaws 2018 is modified to the extent.

The Third Party Certification (Self Certification) of the building plans for residential plotted and commercial of plot size upto 500 sq.mt and height upto 15 mt. / upto 17.5 meter with stilt of 2.5 mt. Whereas for industrial building there shall be no restriction with respect to plot size and height.

Architects empanelled with the concerned Municipal authority shall be authorized to issue building plans in case of self certification as per procedure in sub-clause c).

If any difficulty arises in implementation of these amendments in Punjab Municipal Building Bye Laws or if any clarification or interpretation of these Bye Laws is required, Government shall be Competent authority to issue such clarification or remove such difficulty by way of notification.
